Bridesmaid/FG/Mother “Terms of Sale” Agreement

SPECIAL ORDER MERCHANDISE: All merchandise is individually ordered from our designers for you once a minimum deposit of 50% of the total order price is received. **NOTE: If the individual total is less than \$200 before tax, payment in full is required.** Patsy's will charge, **without prior notification**, the remaining balance to the credit card on file upon dress arrival if deposit option is chosen. *Please use discretion when listing a debit card - Patsy's is not responsible for any overdraft charges you may incur.* In the event that a wedding is canceled or an attendant is no longer participating in the event after a deposit has been placed on merchandise the deposit will not be refunded, and if merchandise has been ordered it remains the responsibility of the customer to pick up the item and pay any remaining balances within 30 days upon its arrival to our salon. Returned and stop payment checks are subject to a \$50 administrative fee. Irregularities are common in natural fabrics and are not considered defective. These variations cannot be controlled by the designer or Patsy's. Merchandise is handmade, therefore slight variations from the sample can occur.

CONFIRMATION AND SIZING: We agree to place your special order and notify you with an approximate delivery date from the designer as soon as it becomes available. Patsy's is not responsible for delays beyond our control or for variation in size and dye lots, although these issues are not anticipated. Special order merchandise is generally sized smaller than ready-to-wear merchandise and therefore we may only recommend sizes according to the manufacturer's size charts. We are not responsible for the accuracy of measurements provided to us by external sources, choosing your size, or for fluctuations in your measurements after the order is placed. Gowns are not made to specific measurements and may require additional alterations to achieve the desired fit.

SHIPPING: Bridesmaids, Flower Girls, and Mother of the Bride/Groom dresses may be shipped for a fee of \$25 plus tax per shipment. If the merchandise is shipped out of the state of Texas, sales tax will not be charged on the merchandise. Shipping details such as the recipient's name, phone number, and address must be provided a minimum of two weeks in advance of the ship date. The shipping fee is for UPS Ground Service (insured/signature required) to the contiguous 48 states only. Additional charges will apply for expedited shipping services. Patsy's does not ship outside of the United States.

CUT OFF DATE: Standard shipping on Bridesmaids, Flower Girls, and Mother of the Bride/Groom dresses is 12 weeks, delivery to the store is approximately 1 week following shipping. Each Bridesmaid, Flower Girl, Mother signed measurement form and payment must be received by Patsy's by the cut off date indicated below for the order to be placed. After this cut off date, a rush charge may occur. Rush charges vary by designer. Patsy's holds Bridesmaids/Flower Girls orders until all forms have been received and all dresses have a deposit to insure dye lot continuity. As the bride, it is your responsibility to verify with Patsy's that all of your Bridesmaids/Flower Girls forms have been received and made their payments by the cut off date.
